Schedule of penalties-2013

Penalty, First Offense, unless specified below, Any person who shall violate any provision of the Municipal Code shall, upon conviction thereof, forfeit not less than \$25 nor more than \$500, together with the costs of prosecution, and, in default of payment of such forfeiture and costs of prosecution, shall be imprisoned in the County Jail until such forfeiture and costs are paid, but not exceeding 90 days.

Penalty, Second Offense, unless specified below, Any person who shall violate any provision of the Municipal Code shall, upon conviction thereof, forfeit not less than \$50 nor more than

\$1,000, together with the costs of prosecution, and, in default of payment of such forfeiture and costs of prosecution, shall be imprisoned in the County Jail until such forfeiture and costs are paid, but not exceeding 90 days
