Resolution# 13-01-02

Waupaca County

The Town Board of the Town of Dayton, Waupaca County, Wisconsin, by this resolution, adopted by a majority of the town board on a roll call vote with a quorum present and voting and proper notice having been given, resolves and orders as follows:

Whereas the Town of Dayton has authority under s. 349.07, Wis. stats. to designate certain town roads as through town highways:

And whereas pursuant to s. 349.07 (8), Wis. stats., the town chairperson, or his or her designee, shall erect stop signs at all the entrances to the through highway from other highways in accordance with s. 349.07 (4), Wis. stats., on or before the effective date of this ordinance.

The Town of Dayton hereby resolves to declare the following town highways as through town highways and directs that stop signs be erected at all intersecting town highways.

- Arbor Street from but not including its intersection with Old Highway 22 to but not including its intersection with Cleghorn Road.
- Cleghorn Road from the north Town line but not including its intersection with STH 22 to but not including its intersection with Main Street.
- Crystal Lake Road from but not including its intersection with STH 22 but not including its intersection with CTHK to the east Town line.
- Crystal Road from but not including its intersection with CTH K to the east Town line.
- Dayton Road from but not including its intersection with STH 22 but not including its intersection with CTH K to but not including its intersection with East Road
- East Road from but not including its intersection with CTH K but not including its intersection with Spencer Lake Road to but not including its intersection with Crystal Lake Road
- Emmons Creek Road from but not including its intersection with Rural Road to but not including its intersection with West Road.
- Holmlane Road from but not including its intersection with Mynard Road to but not including its intersection with Stratton Lake Road.
- Jensen Road from but not including its intersection with Dayton Road to but not including its intersection with East Road.
- Long Cove Drive from but not including its intersection with Cleghorn Road to its west end.
- Main Street from Rural Road to Old Highway 22.
- McCrossen Road from but not including its intersection with Old Highway 22 to but not including its intersection with Raymond Drive.
- Mynard Road from but not including its intersection with STH 22 to but not including its intersection with West Road.

- Old Highway 22 from but not including its intersection with STH 22 at its north end to its intersection with Main Street.
- Parfreyville Road from but not including its intersection with CTH K at its northeast end to but not including its intersection with CTH K at its southwest end.
- Pine Lane from but not including its intersection with CTH K to its intersection with Akron Avenue
- Radley Road from but not including its intersection with STH 22 to but not including its intersection with CTH K.
- Raymond Drive from but not including its intersection with Old Highway 22 to but not including its intersection with McCrossen Road.
- Rural Road from but not including its intersection with CTH K but not including its intersection with Barlow Street and not including its intersection with Main Street and not including its intersection with STH 22 to the North town line.
- Smith Road from but not including its intersection with Rural Road to but not including its intersection with Old Highway 22.
- Spencer Lake Road from but not including its intersection with CTH K to the east Town line.
- Stratton Lake Road from but not including its intersection with STH 22 to the west Town line.
- West Road from but not including its intersection with Rural Road to but not including its intersection with Stratton Lake Road.
- West Road from but not including its intersection with Stratton Lake Road to but not including its intersection with STH 22.
- West Stratton Road from but not including its intersection with STH 22 to but not including its intersection with Holmlane Road.
- Whispering Pines Road from but not including its intersection with Rural Road to the north Town line.

This resolution is effective on January 16, 2013. This resolution will be effective at the time the Town of Dayton has posted signs at those locations.

The town clerk shall properly post this resolution as required under s. 60.80, Wis. stats.
